## **Subject: Invitation - Title 27 Informal Regulatory Workshops**

You are cordially invited to participate in one of four regulatory workshops listed below. The California Environmental Protection Agency's (CalEPA) Unified Program is holding four informal workshops throughout California to share and discuss the proposed amendments to the Unified Program regulations contained in subdivision 4 of Title 27 of the California Code of Regulations.

In general, proposed amendments include deletions of data dictionary elements for the UST Program that are no longer used; trade secrecy claims reported in the California Environmental Reporting System (CERS); Unified Program Agencies reporting the final disposition of complaints in CalEPA's Environmental Complaint Management System; and changes to CUPA-to-State reporting requirements and report formats. Other non-substantial changes include clean-up of regulatory language.

During each workshop, CalEPA will systematically review the proposed amendments to Title 27 and share the intended purpose of each amendment. Workshop attendees will be able to discuss and comment on the proposed amendments as they are presented.

The text of the proposed Title 27 amendments will be posted on the home page of CalEPA's [CERS Central](#) website at least two weeks before the first regional meeting.

**Please note that CalEPA will not be providing guidance on or discussing technical aspects of the California Environmental Reporting System (CERS) during these workshops.**
