Creating a Facility to Report CME Data


How do I report CME data for a facility that is not in CERS?

Answer: This FAQ presumes that you have CME data to report but the facility has not yet been created in CERS. It further presumes that the facility is not part of an existing business organization in CERS.

If the facility is part of an existing business organization you should contact the business to create the facility or request that the business add you as a lead business user to their business organization. If neither is possible, you will need to contact CalEPA Help (<u>CERS@calepa.ca.gov</u>) to add you to the existing business organization as a lead user in order to create the new facility. You will need to delete yourself as a lead user for that business organization once the facility has been created.

1. You cannot create a facility or a business in the Regulator Portal. If you select the 'adding business' tab in the Regulator portal Business tab you will see the following text box referring you to the Business portal to add a business/facility.
